### **Investment Objectives and Strategies**

The Fund's investment objective is to provide long-term capital appreciation and income by investing primarily in equity and fixed income securities of small cap companies based in North America. The Fund may also include similar investments in mid-capitalization businesses. The prior approval of shareholders is required before a fundamental change is made to the investment objective of the Fund. This approval must be given by a resolution passed by a majority of the votes cast at a meeting of the shareholders of the Fund.

Techniques such as fundamental analysis may be used to assess the growth and value potential of an investment which requires evaluating the financial condition and management of each company, its industry and the overall economy. As part of this evaluation, the Manager may analyze financial data and other information sources, assess the quality of management, and conduct company interviews.

### **Risk**

As of June 30, 2021, the risks of investing in the Fund remain as described in the prospectus. The main risk to investors is the market capitalization risk of small companies. Small cap companies are inherently higher risk because of 1) lower trading liquidity, 2) access to capital can be limited, and 3) operational history can be limited/minimal.

The Fund is suitable for investors who are seeking a potential for capital appreciation, have high medium tolerance and have a medium to long-term investing horizon. However, the level of risk associated with any particular investment depends largely on an investor's personal circumstances. Investors can invest a component of their total portfolio in the Fund to provide portfolio diversification. Investors should consider their personal investment profile and consult their financial advisor before making a decision to invest in the Fund.

## **Result of Operations**

The Fund gained 10.2% on the Series A and 10.9% on the Series F and 10.7% on the Series F1 units during the period. The Fund's benchmark (90% S&P/TSX Small Cap Index/10% Russell 2000) was up 18.87% during the period.

It therefore underperformed the Benchmark, which came in part from an underweight position in Energy in the fund. Therefore, in an effort to gain exposure to the Energy sector, two energy names were added, which has increased its overall weighting in Energy to ~13%. The fund was also impacted from an overweight position in Technology, which will remain given the growth potential in the sector from a re-opening of the economy expected in the second half of the year.

The Portfolio Manager believes that the limited number of active managers focusing on small cap stocks, coupled with a relatively robust universe of investment opportunities, provides a durable competitive advantage to uncover market inefficiencies. The Portfolio Manager also favors strong balance sheets, capable management teams and companies with strong economic moats, which help drive outperformance over the long-term.

## **Recent Developments**

The Canadian market was buoyed by growth in the energy sector in Q2. Fueled by an easing of restrictions related to improved vaccination rates and as a result, lower Covid-19 related case globally, the Energy sector had the strongest performance among small caps. As travel-hungry passengers get ready to hit the road, we expect the momentum in energy to continue through the remainder of the year.

In an effort to increase exposure to a re-opening economy, the fund has increased its weighting to the Energy sector to 13.8%, as well as kept an overweight allocation to Technology and Industrials as these cyclical sectors should bode well as restrictions loosen, the economy re-opens and spending accelerates.

Our expectation is for solid but moderate recovery of North American Growth in 2021. We believe small business with solid balance sheet, economic moats and strong management teams will benefit the most from this rebound.

## **Related Party Transactions**

The Manager of the Fund is LDIC Inc. The Manager provides investment and administrative services to the Fund. In consideration for these services the Manager receives a fee based on a percentage of the Net Assets of the Fund calculated daily and payable monthly, as follows:

Series A:	2.00% per annum
Series F:	1.00% per annum
Series F1:	1.50% per annum

The Fund will pay a performance fee to LDIC Inc., plus applicable taxes, at the end of each fiscal year. The performance fee will be 15% of the amount by which the Series NAV at the end of the fiscal year (adding

back the amounts of any distributions paid on the shares of the Fund) (the “ending NAV”) exceeds the target NAV. The target NAV is calculated by multiplying the Series NAV, net of performance fees paid, as at the last performance fee payment date (the “beginning NAV”) by the sum of one plus the return of the Fund’s “benchmark” (the “benchmark return”) over the same period.

As of June 30, 2021, the Manager of the Fund and certain Directors and Officers of the manager held a total of 262,158 shares of the F Series of the Fund and 61,312 Series F1 of the Fund.

**Management Fees**

All management fees are based on the NAV of a series of shares, calculated on each Valuation Date and paid monthly. The management fee for the Fund is 2.00% for Series A, 1.00% for Series F, and 1.50% for Series F1. The breakdown of the services received in consideration of the management fee, as a percentage of the management fee is:

(3) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average Net Asset Value during the period.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a Fund's portfolio turnover in a period, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the Fund.

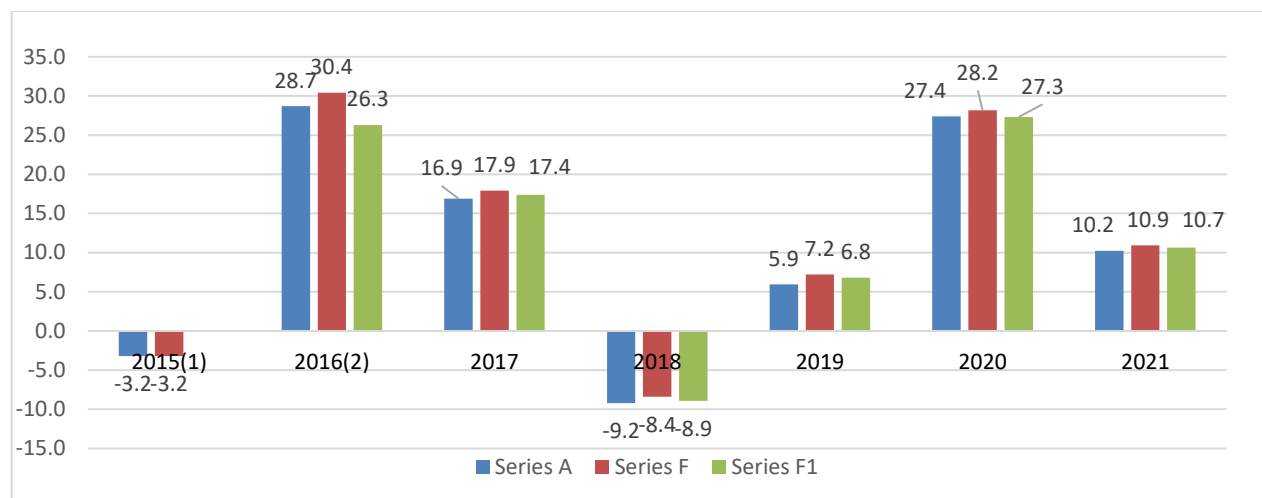

### About the Fund's Benchmark

#### S&P TSX Small Cap Index (90%)

The S&P/TSX Small Cap Index measures the performance of small cap Canadian equity securities listed on the Toronto Stock Exchange. Securities in the index are selected by S&P using its industrial classifications and guidelines for evaluating issuer capitalization, liquidity and fundamentals. The index is float adjusted and market cap weighted and was developed with industry input as the ideal benchmark for those with small cap exposure of the Canadian equity market.

#### Russel 2000 Index (10%)

The Russell 2000 Index measures the performance of the small-cap segment of the U.S. equity universe. The Russell 2000 Index is a subset of the Russell 3000® Index representing approximately 10% of the total market capitalization of that index. It includes approximately 2000 of the smallest securities based on a combination of their market cap and current index membership. The Russell 2000 is constructed to provide a comprehensive and unbiased small-cap barometer and is completely reconstituted annually to ensure larger stocks do not distort the performance and characteristics of the true small-cap opportunity set.
